Inhalation.

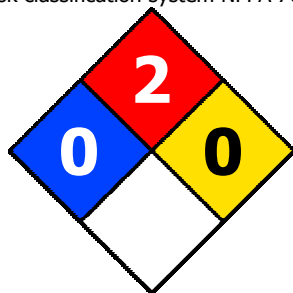
